“AN ORDINANCE ENACTING THE SECOND (2ND) AMENDMENT OF MUNICIPAL ORDINANCE NO. 2012-02,
THE REVISED REVENUE CODE OF CLAVER, SURIGAO DEL NORTE”

Be it enacted by the Sangguniang Bayan duly assembled that:

Section 1. Title Ordinance shall be known as “The Second (2nd) Amendment of Municipal Ordinance No. 2012-02, The Revised Revenue Code of Claver, Surigao del Norte”

Section 2. Amendment. Section 5B.01 Revenue Code is hereby amended as follows

“Section 5B. 01. IMPOSITION. The following rates of rental fees for the use of real and personal properties of this municipality shall be collected as follows:

SECTION. 5. Effectively. This Ordinance shall take effect ten (10) days after receipt of validation and posting at bulletin of the Municipal Hall, Barangay Halls and two other conspicuous places within the Municipality.
