**AN ORDINANCE ENACTING THE AMENDMENT OF MUNICIPAL ORDINANCE No. 2007-02, THE
TRANSPORTATION AND TRAFFIC CODE OF CLAVER, SURIGAO DEL NORTE.**

Be it enacted by the Sangguniang Bayan duly assembled in session that:

SECTION. 1. Amendment. There is hereby amendment to MUNICIPAL ORDINANCE No. 2007-02, THE TRANSPORTATION AND TRAFFIC CODE OF CLAVER, SURIGAO DEL NORTE as follows.

Section 22. One way traffic is hereby regulated when plying along the following municipal streets:

- a. Right or left turn from

“ARTICLE I. ONE WAY TRAFFIC”

Section 22. One way traffic is hereby regulated when plying along the following municipal streets:

- a. Right or left turn from the National Highway of Thirty-seven (37) meters distance heading north along Clarin Street;
- b. Right turn from Felipe L. Parnes St.;
- c. Left turn from Felipe L. Parnes Street of Sixty-five (65) meter distance north bound along Carlos P. Garcia Street fronting both Claver Commercial Building II and Claver Public Market; and
- d. From North heading South of Sixty – five (65) meter distance along Clarin Street fronting Claver Commercial Building I and left turn along Felipe L. Parnes St.;

Section 2. Number Changes on Subsequent provisions:

- (a) Section 22 thereof for “Administrative Provision.” Is hereby changed to Section 23;
- (b) Section 23 for “Penalties” is likewise changed to Section 24; and
- (c) Section 24 for “Effectively” is also changed to Section 25.

Section 3. Effectively. This Ordinance shall take effect upon approval.
