“THE FIVE PERCENT (5%) INCENTIVE OF REAL PROPERTY TAXFIELD COLLECTION ORDINANCE OF THE MUNICIPALITY OF CLAVER, PROVINCE OF SURIGAO DEL NORTE”

WHEREAS, Article 100 a (2) (ii) of the Rules and Regulations Implementing the Local Government Code of 1991 provides authority of the Municipal Government of Claver, among others;

“Subject to provisions of Book II of the Code and applicable laws and upon the majority vote of all the members of the Sangguniang Bayan, enact ordinance, levying taxes, fees and charges prescribing the rates thereof for general and specific purposes, and granting tax exemptions, incentives or reliefs”;

WHEREAS, effective and efficient revenue generation program is essential to maximize the use of resources for development plans, program objectives and priorities of the municipality;

NOW, THEREFORE, be it ENACTED by the Sangguniang Bayan Members duly assembled that:

Section 1. Title – This Ordinance shall be known as “THE FIVE PERCENT (5%) INCENTIVE OF REAL PROPERTY TAX FIELD COLLECTION ORDINANCE OF THE MUNICIPALITY OF CLAVER, PROVINCE OF SURIGAO DEL NORTE”

Section 2. Incentive. – There is hereby a Five Percent (5%) incentive privilege granted to qualified Municipal Revenue Field Collector in the Municipality of Claver, Province of Surigao del Norte from total quarterly field collection of Real Property Tax.

Section 3. Administrative Provision. The Office of the Municipal Treasurer shall require respective Revenue Collectors, for review and approval granting the incentive privilege a periodic Certified Statement of Real Property Tax Field Collection under oath for corresponding payment thereof.

Section 4. Liabilities. Civil servants or persons violating the above provisions shall be prosecuted administratively and or criminally.

Section 5. Effectively. This Ordinance shall take effect upon approval
